The U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of State's list of Specially Designated Nationals or the U.S. Department of State's list of individuals debarred from receiving the Munitions List items.
3. I (We) will abide by all applicable U.S. export control laws and regulations for any products purchased from AirGroup America and will obtain any licenses or prior approvals required by the U.S. Government prior to export or re-export of U.S. supplied products, software or technology.
